DELTAVISION Quick Start Guide – System Startup

1 – Turn on the computers:

- Power on the monitor, camera and SSI (if 7-color).
- Power on the ICMIC and workstation. The order in which they are powered on does not matter.
- Power on the environmental chamber (if installed).

2 – Login and Initialize the system:

- Type in username and password. (default: User: worx Password: [system serial number]).
- Open softWoRx. (icon may be located on desktop, in task bar, or in Start softWoRx the start menu under the Applied Precision folder).
- To startup the microscope, in softWoRx select **File > Acquire (Resolve3D)**.
- Follow the on-screen instructions.

3 - Mount your sample:

- Make sure the appropriate objective is selected in the lens area 1 of Resolve3D.
- Rotate the dichroic turret to the proper position. If a motorized turret is installed, select the desired dichroic in the polychroic section of Resolve3D.
- Select the Info button ③ in the Resolve3D window.
 Enter information under Optical Conditions and note the Recommended Refractive index (RI).
- Place one drop of oil (with recommended RI) on Objective or Coverslip. Mount slide coverslip down in repeatable slide holder.

4 – Focus on sample through Oculars:

- Bring objective up to sample by rotating coarse focus knob towards you just until you see the oil spread.
- Rotate Eyepiece filter wheel to an appropriate channel.
- Observe the filter monitor window to ensure the proper filters are in position. If not, adjust the EX 4 and EM 5 filters accordingly.
- Rotate the port selector knob (located on the front of the microscope base) to the eyepiece.
- Open the EX Shutter from the Joystick Keypad.
- Look through the oculars and rotate the fine focus knob to focus on your sample.
- Use the joystick to scan your slide in x and y to find a region of interest.
- Close the EX Shutter from the Joystick Keypad.

DELTAVISION Quick Start Guide – Image Acquisition

5 – Set up experimental conditions:

- Rotate the port selector knob to the camera.
- Acquire an image. In the image window, select fit to screen.
- Use the Centering Tool O to center the specimen in the image window.
- Find focal plane (location of highest max intensity) using Z bar 6 or Up and Down arrows 7 in Resolve3D.
 NOTE: it may be necessary to lower exposure time if image is saturated (max intensity of 4095).
- Adjust exposure time (3) and %T (2) (Neutral Density) to achieve a max intensity (10) between 2000-2500 for fixed samples or 3-5 times the background (min intensity) for live samples.
- Switch EX filter ④ to the next channel and find appropriate exposure time and %T. Repeat for all channels that will be utilized in your experiment.
- Use the Z bar (6) to scroll up until you reach the top of your sample. Mark the top. (*)
 NOTE: Scroll up until the structures that you are trying to see in your experiment are just slightly out of focus.
- Use Z bar to scroll down until you reach the bottom of your sample. Mark the bottom.
- Return to the middle of your sample. *

6 – Design and Run Experiment:

- Select the Experiment button 1 in the Resolve3D window.
- In the Z Sectioning tab, select the Get Thickness button. This will load the Z thickness you set in Section 3. Make sure that you have elected to start from the Middle of the Sample.
- In the Channels tab, activate the number of channels you wish to use in your experiment. Load the channels using the EX Filter drop-down menu.
- Select the Run Experiment tab. When prompted, select "OK" to save the experiment macro and then "Yes" to save the macro as the default filename (Resolve3D.exp).
- Select the Settings button to change where your image file is saved.
- Enter an Image File Name. Do NOT use spaces or special characters in the file name.

Select the Play Button.

Sectioning Tab:

- OAI (Optical Axis Integration) Scanning:
 - Select the box next to OAI scan to run an experiment that will collect a 2D projection of the 3D data contained within the Z thickness specified.
 - Before deconvolving these files, be sure to select the Deconvolve Projections box in the Deconvolution tool.

Channels Tab:

- To add a reference image, check the box and select where in the z-stack the image will be taken, in what channel and with which exposure settings.
- If DIC is to be used, select POL for the filter sets, and TRANS for the exposure source. Make sure the prism slider is in place and the contrast adjusted appropriately.

Time Lapse Tab:

- Activate the time lapse tab and enter the time between points and total time you wish to collect.
- Tracking and focus options:
 - Cell tracking should be turned on if observing an isolated cell that is expected to migrate in x and y. It will keep the cell within the field of view by moving the stage to compensate for cellular movement.
 - UltimateFocus maintenance will use the infrared laser to maintain the focus set at the start of the experiment.
 - Image based Autofocus will use contrast in fluorescence (or transmitted) light images to find the focal plane.
- If there is significant time between points of your time lapse, you may want to select the "Deconvolve during experiment" option in the Run Experiment tab.

Point Visiting Tab:

- Find and refine the desired points:
 - Mark points using either the bottom right button on the Joystick keypad or the keybad button in Resolve3D.
 - From the Resolve3D window, open the Points List. Without adjusting the microscope focus knob, visit each point and find its focal plane. Select the Replace Point button in the points list to save this Z position.
- Set up the experiment to visit the points :
 - Activate the Points tab, list the points you would like to use in your experiment (i.e. 1-3, 5,10-14).
 - The experiment will apply all Z sectioning, Channels and Time Lapse settings to all points selected.
 - Both UltimateFocus and image based auto focus options can be defined if desired.

Panels:

- A series of images that can be stitched together to form a single large image is a panel experiment.
- Selecting "Get Start" or "Get End" will set the current stage position as the start or end of the panel. (The image will be scanned from upper left to lower right).

Actions:

 During a time-lapse experiment, the user has the flexibility to add any number of actions to specialize the experiment.

Experiment File Location

 All experiment files are saved in the Data Folder (Data1). This folder can be opened from the Main softWoRx window by selecting the Data Folder button or by double clicking on the Data1 folder on the Desktop.

Image Processing

- General Processing Tips:
 - Loading files into processing tools. First, open the tool, then do <u>one</u> of the following:
 - Drag and drop the window ID number of the file into the Input line of the tool.
 - Type the window ID number of the open image file into the Input line of the tool.
 - Drag and drop the image file icon from the Data folder into the Input line of the tool.
 - Many tools have a Details button. This is where you can choose to process only a subset of your data by selecting only certain Z sections, Time Points, etc.
 - Many tools also have a Select Region button. This is where you can select only a particular x-y
 area to process. select the Select Region button then draw a box in your image window. The
 reset button will allow you to erase a selected region.
 - Not all tools automatically save their output. You will be prompted to save unsaved files before closing.
 - Select the shutton to open the image histogram (or use the small histograms located on the top of the image window). This will adjust display scaling but will not alter your experimental data.
- Deconvolution: Select Process > Deconvolve. All other information is loaded from the raw image file.
 Default settings are adequate for the majority of applications. Select Do It.
- Quick Projection: Select View > Quick Project. This will project your 3D data into a 2D format by either Max Intensity, Average or Sum method.
- Volume View: Select View > Volume Viewer. Select the Rotation you prefer then select Do It.

Save As

- Movie: In the image window, select File > Save as Movie. Select the preferred file format (MPEG, AVI or Quicktime), and Frame Rate then select Preview. When the speed of the file looks ok, select Do It.
- Tiff: In the image window, select File > Save as Tiff. Decide whether you would like the Tiff images scaled or unscaled by selecting or deselecting the "Scale Using Min/Max/Exp Values Below." Select the appropriate Output Size then select Do It.

NOTE: *softWoRx* will make a separate Tiff file for every z section and time point in your experiment. Select a subset in Details if you wish.

JPEG Snapshot: In the image window, select File > Save as JPEG. Select Do It.
 NOTE: Do NOT save as JPEG if you hope to quantify your data.
